What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. <i>1st Priority Mortgage, Inc. does not share with nonaffiliates so they can market to you.</i> 	
Joint Marketing	 agreement between nonaffiliated financial companies that ether market financial products or services to you. <i>1st Priority Mortgage, Inc. doesn't jointly market.</i>
